## **Motorcycle Waiver & Event Release Form**

In signing this document, I represent that I am fully knowledgeable of the danger and hazards associated with riding motorcycles. I understand that such activities **may cause serious injury or death**. I certify that I am duly licensed and competent to operate a motorcycle in a safe manner, and the vehicle is in a safe operating condition. I will be riding on public highways and am solely responsible to determine the speed and operational characteristics of my motorcycle while participating in the tour. I am licensed to operate a motorcycle and always carry motorcycle liability insurance as required by law. I hereby release and hold harmless, STAR Touring and Riding Association, any of its executives, members, entities or subsidiaries, any Licensed Chapter of STAR Touring & Riding Association, any of its executives, members, entities or subsidiaries, and Star Motorcycles, Yamaha Motor Corporation USA, any of its executives or employees, against any and all claims, causes of action, or any other liability of any kind arising from my activity of touring by motorcycle/or participation in any event sponsored by same while attending **STAR DAYS 2017, REDWING, MN** events and rides.

### **Photo and Video Release**

I understand that STAR Touring and Riding Assoc., Star Motorcycles, Yamaha Motor Corporation USA, and/or their agents may take photos and videotape of **STAR DAYS 2017** event. I also understand that I may be included in such photo's/video tape and they remain the property of STAR Touring and Riding Assoc/Star Motorcycles/Yamaha Motor Corporation USA and/or their agents and I give my consent to use them as they deem necessary.

I certify that I have no known physical or mental impairment that may affect my safety or the safety of the group. I understand that the choice of wearing a helmet or other protective gear is solely my own and that I am responsible for my compliance with all state laws, including those regarding helmets. I certify that I am not under the influence of any narcotic, alcohol or other drug that may impair my understanding or judgment, and that I will not at any time during the tour operate my motorcycle under the influence of any narcotic, alcohol, drug or prescription drug that would cause impairment. **I also understand that this waiver and release is in force July 15-24, 2017 and covers any and all activities.**
